Potential employees will meet the following expectations.

- Possess a clear testimony of salvation and mature biblical knowledge.
- Provide references that attest to a Christ-like and biblical directed lifestyle.
- Affirm LCC Doctrinal Statement.
- Attend LCC as home church.
- Possess a minimum of a Bachelor's Degree in education.
- Obtain and maintain certification with ACSI throughout employment.

Accountabilities/Responsibilities

1. Represent school in a professional and biblical manner in all aspects and areas of life.
2. Implement LCS instructional objectives.
3. Maintain student gradebooks, records, and curriculum maps within required timeframes.
4. Prepare and submit weekly lesson plans by deadline.
5. Attend and participate in all faculty meetings.
6. Participate in other areas of LCC/LCS ministry outside of the classroom.
7. Communicate with peers, parents, and students in a Christ-like manner.
8. Comply with School Policies and Procedures.
9. Effectively utilizes all instructional technology.
10. Demonstrate Biblical knowledge and a Christian Worldview that is integrated into everyday instruction.
